## The Xerox COLOR REIGNITED Sweepstakes Official Rules and Regulations

The Xerox COLOR REIGNITED Sweepstakes (the "Promotion") begins at 12:00:00 AM Eastern Time ("ET") on May 8, 2018 and ends at 11:59:59 PM ET on July 11, 2018. Xerox Corporation ("Xerox" or "Sponsor") is not responsible for lost, stolen, misdirected, delayed, destroyed or illegible entries.

SPONSOR: The Sponsor of this Promotion is Xerox Corporation, 800 Phillips Road, Webster, NY 14580.

- 1. NO FEE OR PURCHASE NECESSARY TO ENTER OR WIN. PRODUCT PURCHASE WILL NOT IMPROVE THE ODDS OF WINNING.
- **2. ELIGIBILITY:** The Promotion is open to legal residents of the 50 United States, the District of Columbia, and the province of Ontario, Canada who are 21 years of age or older at the time of Promotion entry who receive an invitation from Xerox to attend one of the Xerox COLOR REIGNITED Roadshow events in Rochester, NY, Palo Alto, CA, Lewisville, TX, Toronto, ON, and Chicago, IL (each, an "Event") (upon verification of prize eligibility, misrepresentation of any information will void the entry). This Promotion is nontransferable.

## 4. PRIZES AVAILABLE:

  - Two (2) tickets to watch the game from the Xerox Suite. Game date options will be provided to winner and are subject to availability and Sponsor approval.
  - \$300 food & beverage stipend
